"President Obama has clearly said he will veto this bill. The President's action will protect Americans from going back to a time when they faced bankruptcy due to lifetime caps on coverage, could be denied coverage due to pre-existing conditions or couldn't qualify for Medicaid coverage when struggling to make ends meet.
